As I write, we are working on our Strategic Plan and it has given me pause to think about Auspicious as a Not-for-Profit Arts Organisation. In many ways it is an "impossible organisation". It has grown to become an essential part of the fabric of the arts ecosystem relied on by many hundreds of artists and different funding bodies each year. It exists without the need to seek funding or philanthropic support so we can concentrate exclusively on our task and to not be compromised by the need to seek funds to keep our doors open.

As Executive Director, I would like to take this opportunity to thank our Board of Directors and especially our Chairperson, Sue Hunt. As we have grown, so have the imperatives of Governance. We are very fortunate to have a board that are engaged, challenge us and provide a broad industry insight.


